COMMUNICATIONS

Four County by Mr. Rairigh on behalf of Mrs. Keeler: Third quarter wraps up on March 12. Four County received 570 applications from sophomores despite all tours being held virtually. So far 450 of these students have been placed in programs.

Athletics by Mr. Savage: Bryan won the NWOAL championship in Girls' Basketball and Girls' Bowling. Ten swimmers advanced to the State swimming meet. Swimmers recognized in the All-State team included Kellen Rigg, first team, and the 200 free relay team (Collin, Barrow-Whetro, Ara Alyanakian, Kellan Rigg, and Jackson Miller), second team. Boys' Bowling came in second in the NWOAL for the season. Girls' Basketball finished district runner-up, their best finish since 1992. BCS will observe its annual athletics dead week from July 4 to July 11. Spring sports will begin competitions this month. An additional Nation Signing Day event will be held later this spring and we currently expect three student-athletes to sign to play collegiately: Breven Deckrosh, baseball - Owens CC, Caleb Kepler, football - Ashland University, Shallyn Miley, basketball - Lourdes College.

Curriculum by Mr. Bassett: ACT test was administered to all but 7 juniors who will be presented a make up test this week. State testing will ramp up after spring break and the state has decided a full slate of testing will be conducted. However, test results will not count towards teacher evaluations for this year.

Elementary by Mrs. Cox: Report cards went home on Friday. They came in an envelope for parents to sign and return. The PTO book fair is this week and is only taking place during school hours. The incoming kindergarten parents' meeting is scheduled for March 11. Incoming cubtergarten parents are not required to attend but preschool to kindergarten parents must come.

Middle School/High School by Mr. Alspaugh: The third quarter ends on Thursday. The next issue of Golden Bear News is coming out Friday with highlights from the third quarter. Congratulations to the MS/HS guidance staff. With 70 students going to Four County and a full complement of 1,000 students in the building, they are doing a terrific job of making sure each student completes their requirements to graduate. Congratulations to our art students and faculty as they recently had a very strong showing at an art competition and continue to do so year after year. Congratulations to the Junior High Academics league for winning the Williams County championship. The spring musical is right around the corner. Little Women will be presented in four performances beginning April 9. Tickets go on sale soon for \$10.
